

BOROUGH OF NORWOOD
ORDINANCE 11:06

CAPITAL ORDINANCE TO APPROPRIATE THE SUM OF \$146,189.50 FOR THE UNDERTAKING OF VARIOUS IMPROVEMENTS AND THE ACQUISITION OF VARIOUS EQUIPMENT AND A VEHICLE IN, BY AND FOR THE BOROUGH OF NORWOOD, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, TO TRANSFER AN APPROPRIATION FROM THE BOROUGH'S CAPITAL IMPROVEMENT FUND AND UNEXPENDED BOND ORDINANCE BALANCES AND REAPPROPRIATE SAME TO FINANCE SUCH APPROPRIATION.

WHEREAS, the Borough Council of the Borough of Norwood, in the County of Bergen, State of New Jersey now finds and determines that \$146,189.50 aggregate funded appropriation balances constituting an unexpended capital improvement fund appropriation and unexpended bond proceeds of the Borough's 2008 General Improvement Bonds are not necessary for the purposes for which such capital improvement fund moneys were appropriated and for which such bonds were issued and that it is in the Borough's best interest to use said moneys for costs of the undertaking of various improvements and the acquisition of various equipment and a vehicle, NOW, THEREFORE,

BE IT ORDAINED by the Borough Council of the Borough of Norwood, in the County of Bergen, State of New Jersey (the "Borough"), as follows:

Section 1. It is hereby determined that the funded appropriation balances constituting an unexpended capital improvement fund appropriation and unexpended bond proceeds in the following ordinance are no longer needed for the purposes

Section 2. The Borough is hereby authorized to undertake various improvements and acquire various equipment and a vehicle as follows:

Fire Department

air pack bottles and other firefighting equipment

Emergency Medical Services (EMS)

vital signs monitors for ambulances
carbon monoxide detecting device
laptop computers for electronic charting
generator for EMS Building

Department of Public Works

pick-up truck with plow

Improvements to Borough Buildings
new telephone systems for Borough Hall and
Police Department
records sharing system for Police Department

Said improvements shall include all work, materials and appurtenances necessary and suitable therefor. The sum of \$146,189.50 is hereby appropriated from the funded appropriation balances transferred and reappropriated in accordance with Section 1 hereof to the payment of the cost of the improvements authorized in this Section 2.

Section 3. Said improvements are lawful capital improvements of the Borough having a period of usefulness of at least five years. Said improvements shall be made and undertaken as general improvements and no part of the cost thereof shall be assessed against property specially benefited.

Section 4. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

Section 5. This ordinance shall take effect at the time and in the manner provided by law.


