ALL DOGS AND CATS IN NORWOOD MUST BE LICENSED EACH YEAR.

ANIMALS WILL NOT BE LICENSED WITHOUT PROOF OF A CURRENT RABIES SHOT.
IF YOUR PET'S RABIES VACCINATION EXPIRES PRIOR TO *NOVEMBER OF 2010*, YOUR PET **MUST** BE RE-VACCINATED BEFORE A LICENSE CAN BE ISSUED. PLEASE TAKE ADVANTAGE OF OUR FREE CLINIC IN ORDER TO AVOID A LATE FEE AND/OR A SUMMONS.

NORWOOD WILL CONDUCT A **FREE RABIES CLINIC** FOR DOGS AND CATS TO RECEIVE UP-TO-DATE RABIES VACCINATIONS:

DATE: SATURDAY, FEBRUARY 6, 2010
PLACE: NORWOOD DPW GARAGE, 453 BROADWAY
TIME: 1:00 p.m. to 2:30 p.m.

ALL DOGS/CATS over seven (7) months must be licensed. Rabies Vaccine Certificates should be included with ALL applications. If this is your dog/cat's first Norwood License, a copy of the spayed/neutered certificate must be also be included with your application. This application is being sent to every pet owner on record with the Borough as well as new residents; and a door-to-door canvass may be conducted in the Borough.

FEE: \$13.20 for dogs not spayed/neutered, or \$10.20 if your dog has been spayed/neutered.
\$8.00 for cats not spayed/neutered, or \$6.00 if your cat has been spayed/neutered.
